UNUSUAL FIRE AND EXPLOSION HAZARDS

Isolate from heat, electrical equipment, sparks, and open flame. Closed containers may explode when exposed to extreme heat. Application to hot surfaces requires special precautions. PRECAUTIONS TO BE TAKEN IN USE

VENTILATION
